Project Key Facts

About the project:

The Thames Tideway Tunnel is a major new sewer, urgently needed to protect the River Thames from increasing pollution.

The project will tackle the problem of overflows from the capital's Victorian sewers for at least the next 100 years, and enable the UK to meet European environmental standards.

Thames Tideway Tunnel is one of the largest construction projects of its type in Europe. Construction on the project is due to start in 2016 and will involve 24 construction sites across London.

Work will be split geographically into three main works construction contracts worth a total of around £1.6 billion – west (£300m-£500m), central (£600m-£950m) and east (£500m-£800m).

The project is expected to be financed and delivered by an independent Infrastructure Provider (IP), with its own licence from Ofwat. Thames Water, the Government and Ofwat are continuing to work together to finalise the financing arrangements for the project.

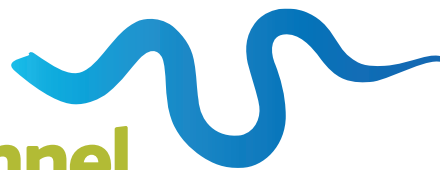
